It is hereby informed to all concerned that the Final Review has been carried out by the Exchange for the selection of Eligible Securities as per Clause No. 10 of the Criteria, for Trading in Deliverable Futures Contract (DFC) and Cash Settled Futures Contract (CSF) Markets, under PSX Regulations No. 13.3.1 of Deliverable Futures Contract Market and Regulations No. 14.2.3 (a) of the Cash Settled Futures Contract Market.

Based on the Final Review, it is hereby notified that:

1. Kohat Cement Co. Limited (**KOHC**) will be shifted from **Category B** to **Category A** of Deliverable Futures Contract from September 2020 Contract (DFC - Sep 2020) due to the Impact Cost of less than 1% during the review period. The Company will be added in Cash Settled Futures Contract from the opening of November 2020 Contract (CSF- Nov 2020).
2. Fauji Foods Limited (**FFL**) will be excluded from the Eligible Securities list for Deliverable Futures Contract with effect from the opening of September 2020 Contract (DFC – Sep 2020) due to the Negative Equity.
3. The following new Securities will be included in **Category B** of Deliverable Futures Contract with effect from the opening of Deliverable Futures Contract of September 2020 (DFC – Sep 2020):
