

RECOMPOSITION OF PSX-KMI ALL SHARE ISLAMIC INDEX

It is hereby informed that the Pakistan Stock Exchange Limited has carried out the re-composition exercise of **PSX-KMI ALL SHARE ISLAMIC INDEX** for the review period January 01, 2025 to June 30, 2025. The re-composition has been carried out on the basis of the criteria of selection of companies as detailed in the brochure of PSX-KMI All Share Islamic Index, which can be downloaded from the website of the Exchange: www.psx.com.pk.
