PSX holds Gong Ceremony on GEM Board Listing of Supernet Limited

A Gong Ceremony was held to announce the listing of Supernet Limited on the Pakistan Stock Exchange's (PSX) GEM Board. The GEM Board has progressively gained traction as it lists Supernet as the third growth enterprise on the Stock Exchange. The Ceremony was attended by COO PSX, Nadir Rahman; Advisor Supernet Limited, Shams Arfeen; CEO Supernet Limited, Jamal Nasir Khan; CEO Topline Securities, Mohammed Sohail and senior management of the participating organizations.

Supernet was founded in 1995 as a Data Network Operator and Internet Service Provider. Supernet is a leading company offering ICT solutions nationwide. It is a major provider of Connectivity Solutions and has, over the last few years, expanded into providing IT solutions, cybersecurity solutions and services, infrastructure solutions and services, and call centre services suite and business process automation.

Supernet issued new capital in order to fund the procurement of fixed assets, invest in its subsidiaries and raise working capital. The capital was raised through the 100% Book Building method. The Issue Size was a total of 21,111,121 ordinary shares. Total demand for 28,499,292 shares was received, thereby the Offer was oversubscribed by 1.35X at the Floor Price of Rs. 22.50 per share.

Speaking at the Gong Ceremony, the COO of PSX, Mr. Nadir Rahman welcomed Supernet Limited as the third equity listing on the GEM Board of PSX and stated, "For a company like Supernet which provides communication/ IT infrastructure solutions for Defence services of Pakistan as well as for various Government departments, federal or provincial, it is a matter of pride for the capital market that Supernet's book building and the listing has taken place on the GEM Board of PSX. This goes to show that PSX's GEM Board is indeed a cost-efficient and appropriate platform to raise capital for SMEs and growth enterprises. The GEM Board is an innovative and progressive platform facilitating growth enterprises and SMEs whereby new and evolving solutions are incorporated on the GEM Board in line with the changing economic and regulatory landscape and in tune with the needs of the growth enterprises."

Alfalah Consumer Index ETF is the first consumer-focused ETF on PSX and it will track the 13th index on the market, the Alfalah Consumer Index.

PSX's journey towards digitisation

Pakistan Stock Exchange is on a journey to digitise various aspects of business which not only includes facilitating market participants towards an online and convenient system but also leads them towards a paperless and environment-friendly way of doing business. The listed companies of the Exchange are already online whereby they can report and announce their financial results through PUCARS (Pakistan Unified Corporate Action Reporting System). PUCARS is an online portal offered by PSX which provides for a system facilitating mandatory posting of announcements by listed companies since July, 2015, for the benefit of all market participants. As part of the process of innovation at PSX, Online Account Opening facility was introduced in January, 2021, which allows (prospective) investors to open their investment accounts digitally, thereby doing away with the need to physically open their accounts and physically submitting their documents. Whereas the online trading system was introduced two decades ago through which investors can invest online through their brokerage accounts, account opening was not online thus far. With this facility, investors can now open their account digitally with convenience and ease. PSX has also made headway with recent advances in digitisation which include a virtual investment tool called 'My Portfolio', E-IPO system and PRIDE, details of which are given as follows:

پی ایس ایکس کا ڈیجیٹل طریقوں کی جانب سفر

پاکستان اسٹاک ایکسچینج کا دربار کے مختلف پہلوؤں کو ڈیجیٹل بنانا اور سرمایہ کاروں کے سفر کی جانب گامزن ہے جس میں نہ صرف اس جانب ترقی کی گئی ہے کہ مارکیٹ کے شرکاء کو آن لائن اور آسان نظام کی سہولت فراہم کی جائے بلکہ انہیں کاروباری امور انجام دینے کے لیے کاغذ کے بغیر (پی پیس) کاروبار، اصول و دست طریقے کی طرف لے جا رہی ہے۔ پی پیس ایکسچینج کی سہولتیں آن لائن ہیں جہاں وہ PUCARS (پاکستان یونائیٹڈ کارپوریٹ ایکشن رپورٹنگ سسٹم) کے ذریعے اپنے مالیاتی نتائج کی اطلاع دے سکتی ہیں اور اعلان کر سکتی ہیں۔ PUCARS ایک آن لائن پورٹل ہے جسے پی ایس ایکس کی جانب سے پیش کیا گیا ہے جو کہ تمام مارکیٹ کے شرکاء کے فائدے کے لیے جولائی 2015 سے سہولتیں کے ساتھ ساتھ کی لازمی طور پر منسلک کے سلسلے میں سہولت فراہم کر رہا ہے۔ پی ایس ایکس میں بہت کم پانچ سال کے قبل کے ایک حصے کے طور پر، جنوری 2021 میں آن لائن اکاؤنٹ کھولنے کی سہولت خلاف کرائی گئی تھی، جو (مکمل) سرمایہ کاروں کو اپنے انویسٹمنٹ اکاؤنٹس کو ڈیجیٹل طور پر کھولنے کی سہولت دیتی ہے، اس طرح یہ اپنے اکاؤنٹس کو ڈیجیٹل طور پر کھولنے اور ٹریڈنگ اور اپنے دستاویزات جمع کرانے کی ضرورت کو ختم کر دیتا ہے۔ وہ بالکل آسان آن لائن ٹریڈنگ کا نظام صارف کو فراہم کر رہا ہے جس کے تحت سرمایہ کار اپنے برادر کچھ اکاؤنٹس کے ذریعے آن لائن سرمایہ کاری کر سکتے ہیں، جبکہ اس وقت تک آن لائن اکاؤنٹ کھولنے کی سہولت دستیاب نہیں تھی اس سہولت کے ساتھ سرمایہ کار اب مناسب طریقے سے اور آسانی کے ساتھ ڈیجیٹل طور پر اپنے اکاؤنٹ کھولنے کے قابل ہیں۔ پی ایس ایکس نے ڈیجیٹل ٹرانزیکشن میں مالی ضرورت کے ساتھ ہی آگے جانب قدم بڑھاتے ہیں جس میں ایک اور چیلنج انویسٹمنٹ ٹول شامل ہے جسے 'My Portfolio'، E-IPO، PRIDE کہا جاتا ہے جن کی تفصیلات ذیل میں موجود ہیں:

PSX Launches 'My Portfolio' – A virtual investment tool

Pakistan Stock Exchange has developed and launched a useful web-based application whereby users can experience real-time market environment, invest in the market, build & manage portfolio(s), and assess their investments in the stock market using virtual money. This is a virtual trading system designed to assist (prospective) investors on how to invest in Pakistan Stock Exchange.

The virtual investment app of 'My Portfolio' has numerous learning benefits for users. It is a tool that allows users to:

- *Understand the stock investment process including buy, sell, commission, profit & loss, stock prices variation etc.
- *Get to know the symbols of listed companies
- *Experience the equity market and the changes/ movement thereof
- *Build a virtual portfolio and assess the gains/ losses thereof Invest and trade in the market without the risk of losing any money
- *Understand the basic concepts of building and managing a portfolio
- *Understand the significance of diversification in a practical environment.

پی ایس ایکس کی جانب سے 'مائی پورٹ فولیو' ایک ویرچوئل انویسٹمنٹ ٹول کا آغاز

پاکستان اسٹاک ایکسچینج کی جانب سے ایک مفید ویب-بیسڈ ایپلی کیشن تیار اور لانچ کیا گیا ہے جس کے ذریعے صارفین حقیقی وقت (ریئل ٹائم) میں مارکیٹ کی صورتحال کا تجربہ کر سکتے ہیں، مارکیٹ میں سرمایہ کاری کر سکتے ہیں، پورٹ فولیو بنا سکتے ہیں اور ان کا انتظام کر سکتے ہیں اور قیاسی رقم (virtual money) کا استعمال کرتے ہوئے اسٹاک مارکیٹ میں اپنی سرمایہ کاری کا اندازہ لگا سکتے ہیں۔ یہ ایک ویرچوئل ٹریڈنگ سسٹم ہے جو پاکستان اسٹاک ایکسچینج میں سرمایہ کاری کرنے کے طریقے کے بارے میں (مکمل) سرمایہ کاروں کی معاونت کے لیے ڈیزائن کیا گیا ہے۔

'مائی پورٹ فولیو' کی ویرچوئل انویسٹمنٹ ایپ صارفین کے لیے سیکھنے کے حوالے سے بہت مفید اور عمدہ ہے۔ یہ ایک ایسا آلہ ہے جو صارفین کو اجازت دیتا ہے:

- *اسٹاک سرمایہ کاری کے عمل کو سمجھیں بشمول خرید و فروخت، کمیشن، منافع اور نقصان، اسٹاک کی قیمتوں میں تغیر وغیرہ
- *درج شدہ کمپنیوں کی علامتوں کے بارے میں جانیں
- *کچھ پی سی مارکیٹ اور اس میں ہونے والی تبدیلیوں اور نقل و حرکت کا تجربہ کریں
- *ایک ویرچوئل پورٹ فولیو بنائیں اور اس کے فوائد اور نقصانات کا اندازہ لگائیں اور رقم کے حوالے سے کسی بھی نقصان کے خطرے کے بغیر مارکیٹ میں سرمایہ کاری کریں
- *پورٹ فولیو کی تعمیر اور انتظام کے بنیادی تصورات کو سمجھیں
- *ایک عملی ماحول میں تنوع (diversification) کی اہمیت کو سمجھیں

My Portfolio is a simple and easy to use tool. Once the user clicks on 'My Portfolio' on the Data Portal Site of PSX, the user is directed to Sign-Up window where he/ she can fill in the basic details requested. After signing up, the user can then login into My Portfolio. The user will now be able to create his/ her first portfolio of investments. Infact, the user is given the option to create multiple portfolios against the same account. The user will get access to his/ her portfolio dashboard from where the user can choose to make a trade, create another portfolio and monitor total return, cash, and total portfolio value, among other parameters of the portfolio. The virtual portfolio tool allows the user to make a trade according to the cash allocated by the user to himself/ herself. The user can also view the portfolio gain/ loss trend, pie charts that displays weightage of equities in portfolio and weightage of sectors in the portfolio. The dashboard also includes summary of the portfolio and transaction history of all transactions conducted.

Overall, 'My Portfolio' is an essential learning tool for (prospective) investors who want to learn about the stock market and building a portfolio of investment without using actual money.

مائی پورٹ فولیو ایک سادہ اور استعمال میں آسان آکر ہے۔ صارف جب اپنی انکس کی لپٹا پرکس سائٹ پر 'My Portfolio' پر کلک کرتا ہے، صارف کو سائن اپ پنل کی طرف جانے کی ہدایت کی جاتی ہے جہاں وہ درخواست کردہ بنیادی تفصیلات کو پُر کر سکتا ہے۔ سائن اپ کرنے کے بعد، صارف پھر مائی پورٹ فولیو میں ڈاک ان کر سکتا ہے۔ صارف اپنا سرمایہ کاری کے حوالے سے اپنا سیدھا پورٹ فولیو بنانے کا اہل ہے۔ درحقیقت، صارف کو ایک ہی اکاؤنٹ کے لیے متعدد پورٹ فولیو بنانے کا اختیار دیا جاتا ہے۔ صارف کو اپنے پورٹ فولیو ذیلی پورڈفک رسائی حاصل ہوگی جہاں سے صارف پورٹ فولیو کے دیگر ایمیٹرز کے ساتھ تجارت کرنے، دوسرا پورٹ فولیو بنانے اور مجموعی ریٹرن، نقد رقم اور مجموعی پورٹ فولیو کی قیمت (value) کی گہرائی کا عمل انجام دے سکتا ہے۔ درپیکل پورٹ فولیو ٹول صارف کو اس بات کی اجازت دیتا ہے کہ وہ صارف کی طرف سے اپنے لیے مخصوص کی گئی رقم کے مطابق تجارت کر سکے۔ صارف پورٹ فولیو میں قائمہ اقتصادان کا رجحان، پائی چارٹس بھی دیکھ سکتا ہے جو پورٹ فولیو میں انکریٹنگ کاوش اور پورٹ فولیو میں سیکڑ کاوش کا پُر کرتا ہے۔ ڈیٹل پورڈ میں پورٹ فولیو کا خلاصہ اور سکے کے تمام نمین دین (لائسنسیشن) کی تاریخ بھی شامل ہے۔

PSX's EIPO System – The digital way forward for subscription of securities

Pakistan Stock Exchange has developed the E-IPO system, a convenient and simplified way to facilitate investors whereby investors can electronically submit application for subscription of securities in an Initial Public Offering (IPO), Offer for Sale and Secondary Public Offering (SPO). This system, called Electronic Initial Public Offering System (PES or PSX E-IPO), is meant not only to expedite and digitise the process of subscription of securities for investors, but also to move them towards a paper-less environment.

The E-IPO system was first utilised in public subscription of Service Global Footwear Limited on April 12-13, 2021. PES can be accessed through the PSX website at the link <https://eipo.psx.com.pk> and payment for the subscription can be made through 1Link and NIFT member banks available for PES.

PES includes features such as auto credit of shares and refund, if any, in the respective account of investor, alerts for upcoming IPOs sent to registered users, and free of cost service.

PES میں جو خصوصیات موجود ہیں ان میں شیڈز کا آؤٹ کرپٹ اور ری-فلڈ، اگر کوئی ہو تو، سرمایہ کار کے متعلقہ اکاؤنٹ میں، رجسٹرڈ صارفین کو بھیجے جانے والے آنکھد IPOs کے لیے الارمز، اور مفت سروس شامل ہیں۔

PSX Develops PRIDE to facilitate Issuers

The newly introduced system called PRIDE (Public Offerings Revolutionized through an Integrated and Digitized Experience) offered by Pakistan Stock Exchange aims to facilitate issuers whereby they will now be able to submit application and documentation for listing online. Through this system, issuers will not need to manually submit application and relevant documents for listing. PRIDE was soft launched on December 20, 2021.

PRIDE, which is an online system designed to automate the listing process from end-to-end, allows Lead Managers, Advisors or Consultants to submit all listing documentation electronically. Through this online portal, work flow will be improved and listing applications will be processed on a fast track basis.

Pakistan Stock Exchange (PSX), Central Depository Company (CDC) and National Clearing Company of Pakistan Ltd (NCCPL) jointly conducted an awareness session for local Securities Brokers on the shared KYC project. Through the shared KYC initiative, investors having designated bank accounts can open an investor account without their physical presence and without the need for submitting any documents physically. It is a complete digital process. The KYC of each customer wanting to open an investor account will be shared by the banking industry with the relevant capital market ecosystem constituents (e.g. CDC) to enable investors to open their investor accounts through the digital platform. The project is also called PSX Shared KYC Project as the PSX management played an important role with the support of the Securities & Exchange Commission of Pakistan (SECP), State Bank of Pakistan (SBP), CDC and NCCPL to initiate this project.

Online Account Opening - Enter the Stock Market Electronically

Pakistan Stock Exchange (PSX) being a dynamic, efficient and robust stock market strives to play its due role as a frontline regulator. PSX is at the forefront of presenting new and innovative products, making regulatory, operational & technological enhancements, and taking numerous steps to promote ease of business for investors, issuers and other market participants. In line with PSX's commitment to make investment on the stock market a convenient process for all, the Online Account Opening facility has been introduced for opening of a trading account with Securities Brokers.

With the process of digitisation of the market functions, the online trading facility was on-boarded for investors almost two decades ago. The online trading system was introduced about 20 years ago whereby investors can invest and trade through their online trading accounts. Online trading has been facilitated by PSX through its KiTS (Karachi Internet Trading System) platform which is the basis of the online trading applications & software provided by brokerage houses to their clients. The Online Trading System enables investors to not only trade online & diversify or rebalance their portfolios, but also view their cash position, trade summaries, trade confirmations, and custody position at the click of a button on their laptops or desktops as well as their mobile phones.

The missing link was that account opening was not online. In January 2021, the Online Account Opening facility was introduced. Whereas the online trading facility was previously available, the online new account opening facility was not. With the advancement in technology, the Covid-19 outbreak, and the Roshan Digital Account platform being

launched which facilitated fulfilling KYC requirements online, Online Account Opening was the next step on the path of innovation and progress for the capital market of Pakistan. Furthermore, Pakistan Stock Exchange along with its cohorts in the capital markets is making efforts with the SECP to make the KYC requirement into a unified system whereby banks and other market entities will have a singular KYC database which they would be able to share and utilise for the purposes of account opening of applicants. This will make redundant the process of initiating KYC formalities every time an individual wants to open an account with any of the market entities.

Applicants can now conveniently open a stock market investment account no matter where they are located. Already, there are more than 50 brokerage houses that are offering the Online Account Opening facility. Prospective investors can choose from a range of brokerage houses that offer Online Account Opening by clicking on the following link on the PSX Website:

The process of online account opening is a simple one. It involves filling out the online account opening form available on the brokers' website, filling in the necessary details and submission of requisite documents online. The documents required for online account opening are:

Copy of valid and Attested CNIC/NICOP/ARC/POC/Passport of the Main Applicants.

Copy of valid and Attested CNIC/NICOP/ARC/POC/Passport of the Join Applicants.

Copy of valid and Attested CNIC/NICOP/ARC/POC/Passport of the Nominee (optional – only for Single Accounts).

Attested Copy of Power of Attorney (if contact person is other than main applicant), duly attested by notary public.

Employee Card / Job Card for salaried person. Company's letter head for business individuals mentioning the name, CNIC and designation etc.

Salary Slip for salaried individual. Income statement for Business Individuals or monthly income mentioned on company's letterhead.

Copy of Utility Bill/Driving License/Insurance Policy/Rent Agreement (If address is not as per CNIC).

Copy of Zakat Declaration of the Applicant and the Joint Applicant (if applicable). In case of Non-Muslim, an Affidavit shall be submitted.

Note: Non-resident/ foreigners shall submit the documents duly attested by either notary public or Consul General of Pakistan having jurisdiction of the Applicant(s).

After the documents are submitted, the back-end process begins. The documents are verified by NCCPL and a verification code is generated and communicated via SMS by NCCPL to the customer to complete and acknowledge the verification. The customer can then submit his/ her payment cheque to the brokerage house in order to begin investing in securities listed on Pakistan Stock Exchange.

The Online Account Opening facility is an innovative and ingenious technological resource to ensure that investors are able to open an account for investing in Pakistan's stock market regardless of where they are located. With about 50% of the local populace living in the rural and far flung areas, the Online Account Opening facility is a definitive method for enabling the peripherally located population to also take part in the investment scene on the stock market without having to travel all the way to a brokerage house physically. Similarly, for overseas Pakistanis, this is also a very valid option of account opening as this will allow them to access Pakistan's capital market while they are living abroad.
